 - c) Copy of Trade License.

Each page of the aforementioned documents should be signed by the bidder to establish the bidders eligibility to perform the supply of materials if its bid is accepted.

The supplier will be responsible for any increase in prices, taxes and duties. Any increase in taxes and statutory duty after the approval of rates shall be borne by the bidder.

2. Payment shall be made after satisfactory execution of the order and supply of items in satisfactory condition. The decision of the District and Sessions Judge, Tinsukia towards satisfaction of quality of material shall be final. Payment of the item supplied under purchase order will be paid on receipt of complete consignment and checking of the items and on production of the bills in triplicate.
3. The District and Sessions Judge, Tinsukia reserves the right to accept or reject any or all the tenders in part or full without assigning any reason whatsoever.



4. The District and Sessions Judge, Tinsukia is not bound to accept the lowest tender and the number of items required may increase or decrease.
5. District and Sessions Judge, Tinsukia reserve the right to award the work to one or more bidders. No communication shall be made in this regard except the selected firm / tenderer/bidder.
6. The decision of the District and Sessions Judge, Tinsukia in all respect shall be final and binding on all.
