5. Calling of the candidates for the said interview/Viva-Voce is purely provisional and does not mean acceptance of their candidature, which shall be further scrutinized by the Interview Board, which reserves the right to reject the candidature of any candidate at any time.
6. Canvassing directly or indirectly shall result in disqualification of the candidature.
7. The Final Selection will be made on the basis of the marks obtained by the candidates in the said interview/viva-voce to be assessed by the interview Board.
